Ben Salkowe - Principal reported to the board that Academically, Equipo is currently highly rated under the Nevada School Performance Framework (NSPF) Report Card, with the middle school program earning a 5-star rating and the high school program earning a 4-star rating.

Equipo's middle school and high school also met standards on the 2021-22 SPCA's Academic Performance Framework and received 79.1 and 75.7 points respectively.

According to the most recent Organizational Performance Framework, Equipo was found to have met the standard for FY22 and earned 86.30 points (out of 100) which was approved at the December 16, 2022 SPCSA Board meeting. Additionally, Equipo received a Meets Standards rating on SPCSA's Financial Performance Framework for FY22.


