The purpose of this letter is to notify you about important information regarding your child's school and how its Title III funding is used.

## **School Specific Actions**

Equipo Academy is using allocated Title III funding to:

- **Increase family engagement** for Emergent Bilingual students by organizing various events specifically for their families, creating a supportive environment for active participation in their children's education.
  - Last school year we were able to organize two family events, one in March and one in May (see attached images),
     we used the Remind group that we created specifically for EB families to communicate about events.
  - Additionally, during our recent Open House at Equipo Academy, paraprofessionals who work closely with EB students were present to meet and interact with families, further strengthening the connection between school staff and the community.
- Implement professional learning opportunities by organizing professional development sessions led by the Director of Emergent Bilingual Student Programs, specifically designed to address the needs of EB students. These sessions provide teachers and paraprofessionals with valuable strategies and insights.
  - During our last PD led by Mr. Espinoza teachers were asked to "put themselves in the EB students' shoes" and better understand the importance of differentiation.
  - In an upcoming PD, Mr. Espinoza will lead a session about translanguaging in the classroom. Moreover, we have offered differentiated professional development for our paraprofessionals where we go over expectations, strategies and concerns.
  - Additionally, the EB coordinator (Ms. Curiel) holds regular check-ins with paraprofessionals to ensure they are continuously supported and have the resources necessary to meet the needs of EB students effectively.
- Create and implement individual language learning plans for students who are emergent bilingual
